TERMS AND CONDITIONS

AB MFB stands for AB Microfinance Bank Nigeria Limited.

1. The issuance and usage of the Debit Card shall be in accordance with the Central Bank of Nigeria regulations.
2. The cardholder shall use his Debit Card strictly in accordance with the banking and financial control regulations of the CBN.
3. Non-compliance with these regulations shall render the cardholder liable under the relevant regulations and in such event, the cardholder may be deactivated, either by the Bank, regulatory authorities, or governing law, from holding or use of the Debit Card.
4. In case of multiple account ownership, the Bank reserves the right to decide on the number of customer accounts which may be linked to or accessed by the Debit Card.
5. The Debit Card shall remain in the cardholder's possession and shall not be handed over to anyone else. The pin shall also remain secret known only to the cardholder.
6. The Debit Card is the property of the bank and is required to be returned unconditionally and immediately to the Bank upon request by the Bank.
7. The Cardholder shall immediately notify the bank upon loss or theft of the Debit Card or forgotten, compromised or accidentally divulged PIN.
8. Any financial loss arising out of unauthorized use of the Debit Card till such time as the Bank receives notice of loss of Debit Card shall be the liability of the cardholder.
9. A new Debit Card will be issued in lieu of a lost Debit Card at such fee as maybe prescribed by the Bank
10. Use of the Debit Card is subject to the availability of funds in the cardholder's account with the Bank.
11. The Bank reserves the right to cancel the Debit Card and stop its use at any time.
12. A cardholder shall be permitted to withdraw cash up to the maximum amount and transaction number per day, as prescribed by the Bank for time to time.
13. The Debit Card is not transferable. Customers shall be given computer generated PIN that will enable them to activate and use the Debit Card.
14. The bank has the express authority to debit the account(s) linked with cardholders' Debit Card for the value of cash transactions and any other applicable fee(s) affected by the use of the Debit Card.
15. The Cardholder expressly authorizes the Bank to debit the designated account(s) with the transaction fees and service charges from time to time.
16. The fees for the use of this service shall be prescribed by the Bank from time to time in accordance with industry standards.
17. The transaction record generated by the Bank will be conclusive and binding on the Cardholder unless verified otherwise and corrected by the Bank. The verified and corrected amount will thereafter be binding on the cardholder.
18. The Debit Card is acceptable at all ATMs in Nigeria belonging to any of the institutions authorized by the CBN.
